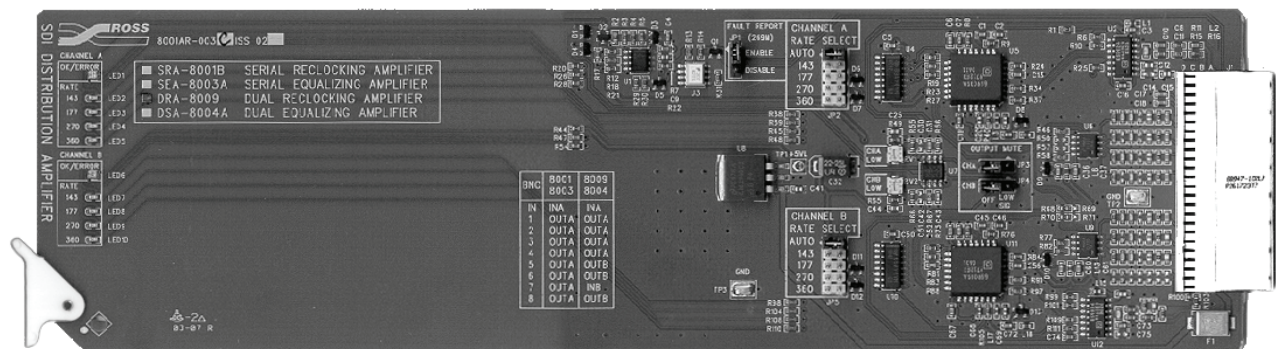

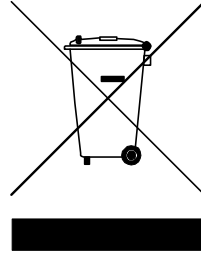

Overview

The **DRA-8009** Dual Auto-Reclocking Amplifier is for use in systems where signals, of more than one serial digital standard, are distributed. Each channel has a five-position jumper that allows the operator to manually select from four allowed input signal rates, or to operate in automatic mode.

The **DRA-8009** is a great rack-space saver because two amplifiers are contained on one DA card. Twenty amplifiers (ten cards) can be contained in a 2 RU frame. Because two amplifiers share one card, the cost per amplifier is the lowest possible. One amplifier has 4 outputs, the other amplifier has 3 outputs. The **DRA-8009** operates on all serial digital standards, from 143Mb/s up to and including 360Mb/s.

In automatic mode, the amplifier automatically detects the current standard, adjusts the reclocking rate, and equalizes up to 300m (1000 ft.) of Belden 1694A input cable. Alternatively, the operator may choose to override the automatic mode capability in order to reclock only at a specifically selected input signal rate. Special measures have been taken to ensure excellent return loss on both input and output. This guarantees error-free performance with short cables.

A very useful feature of the **DRA-8009** is the card-edge LED status indicators, which confirm the presence of an input signal capable of equalization.

The **DRA-8009** is designed to operate within the RossGear 8000-series digital products frame. Ten cards can be installed in a Ross 2 RU frame, and four amplifiers in a Ross 1-rack unit frame. This amplifier also fits Leitch* 6800-series frames.

Functional Block Diagram

The following block diagram outlines the functions of the **DRA-8009** card. Note that the BNC designations are noted in brackets after each SDI designation. Refer to the section, “**Cable Connections**” in this guide, for information on connecting cables to the **DRA-8009** card.

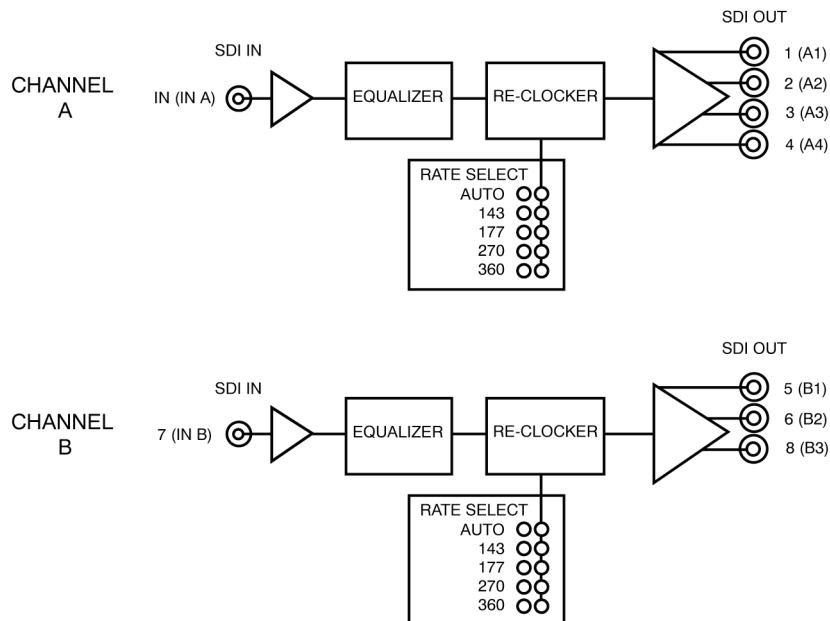


Figure 1. Simplified Block Diagram of DRA-8009 Functions

Documentation Terms

The following terms are used throughout this guide:

- “**Frame**” refers to the **DFR-8104A** and **DFR-8110A** frames that house the **DRA-8009** card.
- All references to the **DFR-8104A** and **DFR-8110A** also include the **DFR-8104A-C** and **DFR-8110A-C** versions with the cooling fan option. See the respective User Manuals for details.
- “**Operator**” and “**User**” both refer to the person who uses the **DRA-8009**.
- “**Board**”, “**Card**”, and “**Module**” all refer to the **DRA-8009** card itself, including all components and switches.
- “**System**” and “**Video system**” refers to the mix of interconnected production and terminal equipment in which the **DRA-8009** operates.

Static Discharge

Whenever handling the **DRA-8009** and other related equipment, please observe all static discharge precautions as described in the following note:



Static discharge can cause serious damage to sensitive semiconductor devices. Avoid handling circuit boards in high static environments such as carpeted areas, and when wearing synthetic fiber clothing. Always exercise proper grounding precautions when working on circuit boards and related equipment.

Unpacking

Unpack each **DRA-8009** you received from the shipping container, and check the contents against the packing list to ensure that all items are included. If any items are missing or damaged, contact your sales representative or Ross Video directly.

Board Installation

Use the following steps to install the **DRA-8009** in a RossGear 8000 series digital distribution frame:

1. Refer to the User Manual of the RossGear 8000 series frame, to ensure that the frame is properly installed according to instructions. If this card is to be installed in any compatible frame other than a Ross Video product, refer to the frame manufacturer's manual for specific instructions.
2. Please note that heat and power distribution requirements within a frame may dictate specific slot placement of cards. Cards with many heat-producing components should be arranged to avoid areas of excess heat build-up, particularly in frames using convectional cooling.
3. After selecting the desired frame installation slot, hold the **DRA-8009** card by the edges and carefully align the card edges with the slots in the frame. Then fully insert the card into the frame until the rear connection plug is properly seated.

BNC Labels

Affix the supplied BNC label, as per the included instructions, to the BNC area on the rear of the rack frame.

Cable Connections

This section provides instructions for connecting cables to the **DRA-8009** when mounted in RossGear 8000 series Digital Products Frames. The cable connectors on the rear of the frame are marked for distribution amplifiers having one input and eight outputs.

Connect the input and output cables according to the frame rear panel connections diagram in the following figures. The inputs are internally terminated in 75 ohms. It is not necessary to terminate unused outputs.

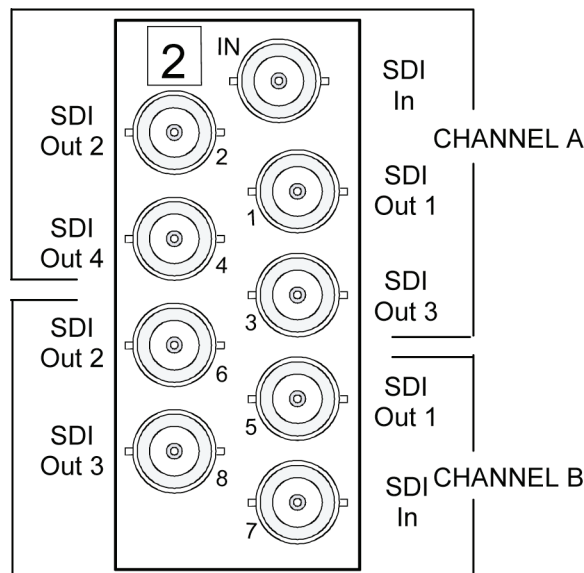


Figure 2. BNC Designations for RossGear DFR-8110A (2RU frame)

Jumper Locations

The following section describes the user configurable jumpers on the **DRA-8009**.

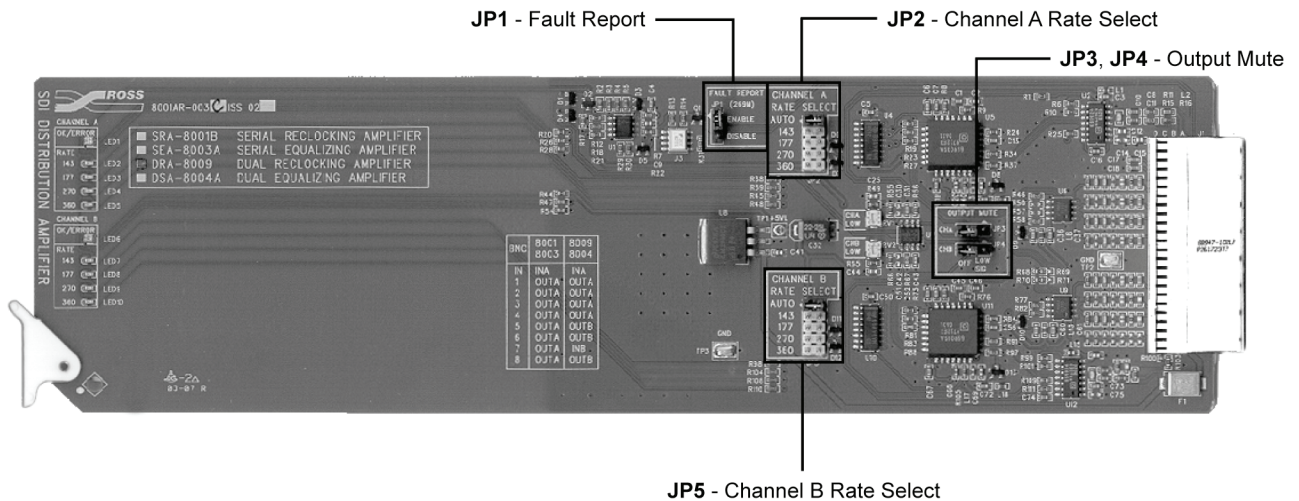


Figure 3. Jumper Locations

Fault Report – JP1

Select SMPTE 269M Fault Reporting, **ENABLE** or **DISABLE**, via **JP1**. The default is **ENABLE**. Refer to the Chapter “SMPTE 269M Fault Reporting” for complete details.

Rate Select – JP2 and JP5

This five-position jumper (**JP2** for Channel A and **JP5** for Channel B) allows you to manually select which rate is input to the **DRA-8009**. It can be set in the positions as described in the following table.

Table 1. Rate Selection Jumper Functions

Rate Select	Function	Description
AUTO	Auto-Reclocks	The DRA-8009 will automatically seek out the input signal data rate, and reclock the signal (default setting). The LED corresponding to the data rate is lit.
143	Reclocks 143Mb/s ONLY	The card will only reclock an input signal at 143Mb/s. If another data rate is input, the rate indicator LED will shut off and the output will be muted.
177	Reclocks 177Mb/s ONLY	The card will only reclock an input signal at 177Mb/s. If another data rate is input, the rate indicator LED will shut off and the output will be muted.
270	Reclocks 270Mb/s ONLY	The card will only reclock an input signal at 270Mb/s. If another data rate is input, the rate indicator LED will shut off and the output will be muted.
360	Reclocks 360Mb/s ONLY	The card will only reclock an input signal at 360Mb/s. If another data rate is input, the rate indicator LED will shut off and the output will be muted.

In most circumstances, this jumper will be left in the **AUTO** position. However, if you require a signal path to have a valid signal of a specific data rate, you can force the card into manual mode. If this is the case, we would suggest putting the Output Mute jumper into the Low Signal (**LOW SIG**) position. The output of the card would then mute if an incorrect data rate is applied to the input, or if the input signal became too weak for the input equalizer to compensate for.

Output Mute – JP3 and JP4

There is an Output Mute jumper for each Channel – **JP3** is for Channel A, and **JP4** is for Channel B.

Select one of the following options as follows, to enable or disable the **Output Mute** option for a channel:

- **LOW SIG** — output will be muted if the input signal degrades to the point that the input EQ can no longer guarantee error-free performance. When the OK / ERROR LED is Red for that Channel, the outputs will be muted.
- **Off** — the card will work to the limits of the input stage. This is the default setting.

LEDs

The front edge of the card has LED indicators which show the status of the amplifier, and the data rate of the signal passing through the card. They are described in the following figure and tables.

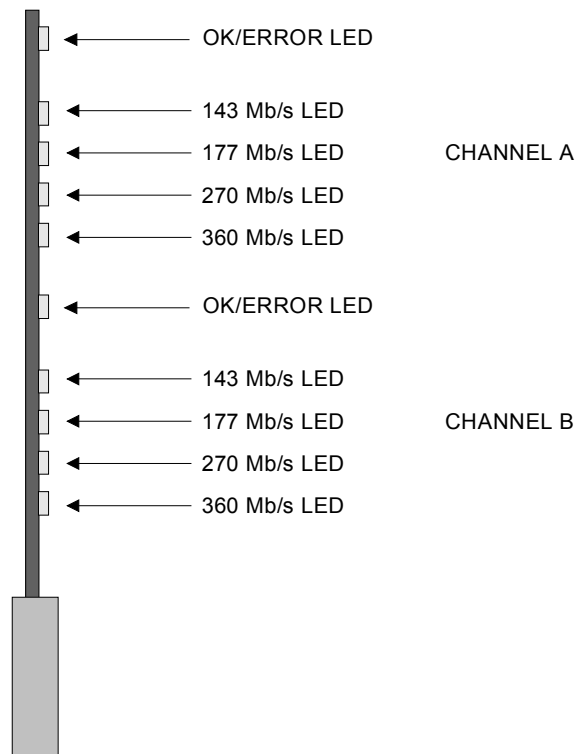


Figure 4. Card-edge LEDs

Channel A LEDs

The following table describes the LED indicators for Channel A located on the front edge of the card.

Table 2. Channel A LED Status Indicator Descriptions

LED	Reference	Status Description
OK / ERROR (Green / Red)	Input OK / Error	When green, Channel A of the card is operating correctly. This indicates that the input signal is suitable for achieving error-free performance, and is within the capability of the cable equalizer to restore the signal. When red, the input signal is too low or absent. In some circumstances, the signal may still be restored correctly but the circuits will be working close to the limit of their capability, and reliability cannot be assured.
Rate (Yellow)	143Mb/s	One of these four yellow LEDs will be lit if the input signal is one of the four SDI data rates and is suitable for achieving error-free performance, and is within the capability of the cable equalizer to restore the signal. They show the data rate of the signal passing through the DA. If all are off, or the indication is not stable, then the input signal may be absent or the reclocking circuit is not locked.

Channel B LEDs

The following table describes the LED indicators for Channel B located on the front edge of the card.

Table 3. Channel B LED Status Indicator Descriptions

LED	Reference	Status Description
OK / ERROR (Green / Red)	Input OK / Error	When green, Channel B of the card is operating correctly. This indicates that the input signal is suitable for achieving error-free performance, and is within the capability of the cable equalizer to restore the signal. When red, the input signal is too low or absent. In some circumstances, the signal may still be restored correctly but the circuits will be working close to the limit of their capability, and reliability cannot be assured.
Rate (Yellow)	143Mb/s	One of these four yellow LEDs will be lit if the input signal is one of the four SDI data rates and is suitable for achieving error-free performance, and is within the capability of the cable equalizer to restore the signal. They show the data rate of the signal passing through the DA. If all are off, or the indication is not stable, then the input signal may be absent or the reclocking circuit is not locked.

SMPTE 269M Fault Reporting

Overview

The SMPTE 269M Fault Reporting system, also known as a SMPTE “alarm”, provides an indication if one or more frame cards encounter a fault or an abnormal condition. The **DRA-8009** card provides a jumper to enable SMPTE-269M fault reporting. The card connects by means of an internal interface circuit to an auxiliary Telco connector on RossGear 8000 series frames. When the frame connection is interfaced with a customer-designed system of LEDs or audible alarms, faults can be traced to a specific frame when a card fault occurs within that frame.

The following diagram illustrates a general arrangement for SMPTE 269M alarm reporting:

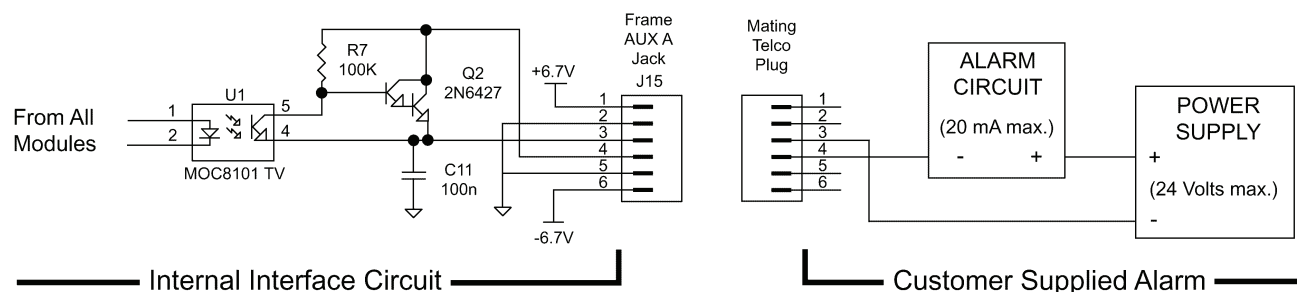


Figure 5. SMPTE 269M Alarm Reporting: Internal interface and typical connections

Jumper Setup

If fault reporting for the **DRA-8009** is desired, use jumper **JP1 - FAULT REPORT** to set up the card.

1. To access the jumper, remove the card from the frame by pressing down the white card ejector tab and pulling the card from the frame slot.
2. Observing all static discharge and handling precautions, place the card with the component side facing up on a clean flat surface.
3. To enable SMPTE fault reporting, set jumper **JP1** to **ENABLE** position.
4. To disable SMPTE fault reporting, set jumper **JP1** to **DISABLE** position.

This completes the procedure to set up the Fault Report Jumper.

Frame Connections

The SMPTE 269M Fault Reporting connection on RossGear 8000 series frames is provided by the auxiliary Telco connector, **AUX A**, for interfacing with a customer-designed alarm system.

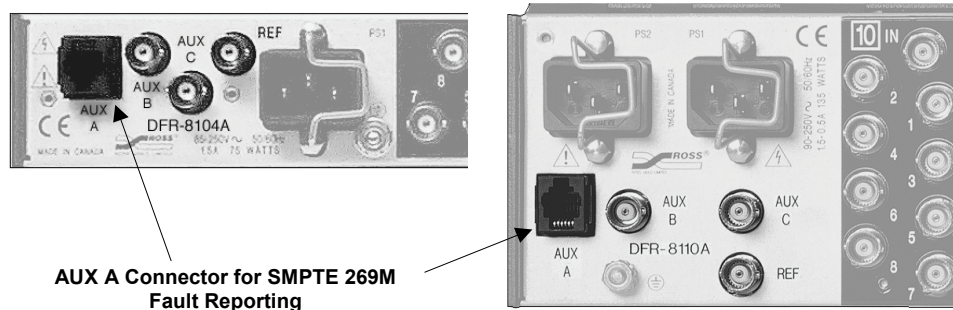


Figure 6. SMPTE 269M Alarm Reporting Frame Connections

Details

The fault report contacts are closed when the card detects an internal failure or a power loss condition. The fault report will pulse off for 1 to 2 ms about every 16ms if the input signal is low or missing.

Some internal failures are:

- Failure of the card to initialize
- Failure in the fault reporting circuitry
- Failure to detect a valid input signal to the card

For additional information on alarm system design, refer to the SMPTE document “**ANSI/SMPTE 269M – 1999**”.

Troubleshooting Checklist

Routine maintenance to this RossGear product is not required. In the event of problems with your **DRA-8009**, the following basic troubleshooting checklist may help identify the source of the problem. If the card still does not appear to be working properly after checking all possible causes, please contact your Ross Video products distributor, or the Ross Video Technical Support department at the numbers listed under the “Contact Us” section at the end of this manual.

1. **Visual Review** – Performing a quick visual check may reveal many problems, such as connectors not properly seated or loose cables. Check the card, the frame, and any associated peripheral equipment for signs of trouble.
2. **Power Check** – Check the power indicator LED on the distribution frame front panel for the presence of power. If the power LED is not illuminated, verify that the power cable is connected to a power source and that power is available at the power main. Confirm that the power supplies are fully seated in their slots. If the power LED is still not illuminated, replace the power supply with one that is verified to work.
3. **Reseat the Card in the Frame** – Eject the card and reinsert it in the frame.
4. **Check Control Settings** – Refer to the Installation and Operation sections of the manual and verify all user-adjustable component settings.
5. **Input Signal Status** – Verify that source equipment is operating correctly and that a valid signal is being supplied.
6. **Output Signal Path** – Verify that destination equipment is operating correctly and receiving a valid signal.
7. **Card Exchange** – Exchanging a suspect card with a card that is known to be working correctly is an efficient method for localizing problems to individual cards.

Warranty and Repair Policy

The RossGear **DRA-8009** is warranted to be free of any defect with respect to performance, quality, reliability, and workmanship for a period of FIVE (5) years from the date of shipment from our factory. In the event that your RossGear **DRA-8009** proves to be defective in any way during this warranty period, Ross Video Limited reserves the right to repair or replace this piece of equipment with a unit of equal or superior performance characteristics.

Should you find that this RossGear **DRA-8009** has failed after your warranty period has expired, we will repair your defective product should suitable replacement components be available. You, the owner, will bear any labor and/or part costs incurred in the repair or refurbishment of said equipment beyond the FIVE (5) year warranty period.
