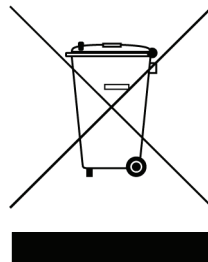

Overview

The VFR-7210 Video Products Frame accommodates up to ten RossGear 7000 series Distribution Products.

The frame employs rugged aluminum construction, which provides superb heat dissipation, as well as the highest quality connectors and a durable finish. Additionally, carefully placed ventilation holes in the rack frame, sides and door guarantees that your Distribution Products will run cooler than in competitive frames.

The following features are included for the VFR-7210:

- Accommodates 10 amplifiers in 2 rack units
- Aluminum construction for increased heat dissipation
- Removable frame door for accessibility
- Optional module extender for servicing
- Power switch and fuse is accessible from front of the rack frame
- PowerLock cord retainer mechanism guards against accidental power loss
- 5-year transferable warranty
- RossGear frames also accept Leitch¹ analog video products

Installing the VFR-7210

This section provides information for installing your VFR-7210 and ensure proper ventilation.

Before You Begin

Before proceeding with the installation, ensure that you review the following notes.

Static Discharge

Throughout this chapter, please heed the following cautionary note:



ESD Susceptibility — *Static discharge can cause serious damage to sensitive semiconductor devices. Avoid handling circuit boards in high static environments such as carpeted areas and when synthetic fiber clothing is worn. Always exercise proper grounding precautions when working on circuit boards and related equipment.*

Unpacking

Unpack each VFR-7210 you received from the shipping container and ensure that all items are included. If any items are missing or damaged, contact your sales representative or Ross Video.

Mechanical Installation

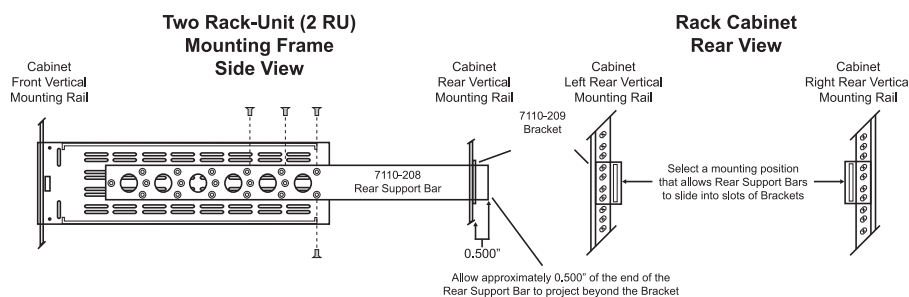


Figure 1.1 Installing the Support Brackets

The VFR-7210 mounts in the rack cabinet by means of four screws through the front mounting flanges. This should normally be sufficient to carry the load, including weight of cables. In some cases, (mobile trucks, etc.) it may be desirable to also support the rear of the frame. Rear support brackets (Ross part #FSB-7110) are available for a nominal cost. The rear support bars can be attached to the VFR-7210 in six possible positions (**Figure 1.1**).

Use the following procedure to install the support brackets:

1. Choose the position that suits the cabinet depth and will give approximately a 0.5” projection beyond the previously mounted bracket.
2. Using four screws per bracket, as shown in **Figure 1.1**, attach both bars.
3. Mount the frame to the front rails of the rack cabinet using rack screws.
4. At the rear of the cabinet, slide the bracket slots over the rear of the support bars and secure to the cabinet rear rails with rack screws.

This completes the procedure for installing the support brackets.

Ventilation

To minimize heat buildup and improve module reliability, maintain a blank rack space both above and below each installed chassis.

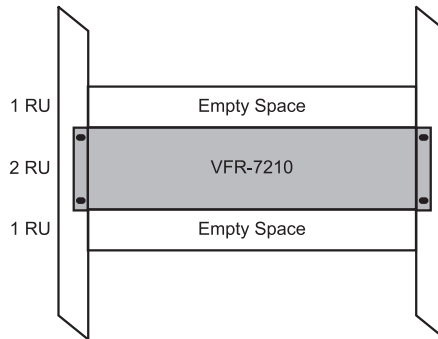


Figure 1.2 *Frame Stacking*

Power Supply PS-7813

The VFR-7210 frames support two independent 13.5 volt PS-7103 power supplies for redundancy. Turning the power supply off before inserting or removing it from the frame will ensure longer connector life.

Video Input and Output Cables
